Taiwan is one of the fastest-growing offshore wind markets in Asia and at the same time possibly the most accessible one. Most of global offshore wind developers have established in the Taiwan market with confidence and optimism in Taiwan's determination to achieve energy transformation goals and Net-Zero emission targets by 2050. More international and domestic industrial players are actively entering round 3 market auction in Taiwan.

Taiwanese offshore wind industry is growing fast and looking for cooperation with foreign companies with knowledge and solutions for the entire value chain especially when floating wind projects potentially become a better solution in the deeper water zone in round 3. The Norwegian offshore and maritime expertise can play a key role in the future development of offshore wind in Taiwan, NORWEP offshore wind delegation to Taiwan aims to open more business opportunities for NORWEP Partners in Taiwan's round 3 project of 15GW.
